MEMORANDUM OF UNDERSTANDING

AGREEMENT FOR USE OF THE LAW ENFORCEMENT
DRUG INFORMATION RESOURCE

PURPOSE OF AGREEMENT

This document constitutes an agreement between the Oklahoma State Bureau of Investigation (OSBI) and _____ (User) as to the use of information contained within the OSBI Law Enforcement Drug Information Resource (LEDIR). The OSBI agrees to provide to User, at no charge, access to the OSBI LEDIR via a secure password and User ID. In exchange User agrees to use such service and information for authorized purposes only. This agreement outlines the rights, responsibilities, and requirements of the OSBI and the Oklahoma County District Attorney's Office.

USE, ABUSE OR DAMAGE TO EQUIPMENT

The information and service provided pursuant to this agreement may not be modified, changed, exchanged, replaced or removed without prior written approval of the OSBI.

User agrees to use the service and information contained within the OSBI LEDIR only for purposes authorized by the OSBI only.

User agrees not to provide User's password to any other person without prior written permission of the OSBI and to take reasonable efforts to maintain the security of that password and the OSBI LEDIR.

OSBI specifically reserves the right to restrict access to the OSBI LEDIR at any future point for any reason and upon such a decision, revoke Users password. OSBI will make all reasonable efforts to advise User of such decision in advance.

INDEMNIFICATION OF THE OSBI

The User agrees to abide by all regulations, rules, and laws of the United States, and the state of Oklahoma in the use of the OSBI LEDIR. The User also agrees to abide by all current or future regulations, rules and statutes regarding the use of any such equipment.

The User agrees to indemnify and hold harmless the OSBI, its Commissioners and employees from and against any and all claims (civil or criminal), demands, actions and suits (civil or criminal) arising out of or involving the use of the OSBI LEDIR subject to this agreement by the Oklahoma County District Attorney's Office.

The User agrees and understands that while the OSBI makes and will continue to make all reasonable efforts to maintain the accuracy of all information contained within the OSBI LEDIR and to keep all information therein current and up-to-date, the OSBI does not warrant or guarantee the accuracy and currency of such information contained within. User agrees and understands that the use of such information and service is at his or her own risk.
